## D. STUDENT RUN PRODUCTIONS (STREAMING OF AUDIO and/or VIDEO and DELAYED TELECASTING/CABLECASTING)

The rights fee for events streamed by student run production will be subject to pay 25% of the listed non-affiliate rights fee for audio or video and 25% of DELAYED Telecasting Fee if the following conditions are met:

### 1. Student Run Production - STREAMING Audio or Video:

- a. The broadcast is entirely student run with production and broadcast roles occupied by current students only.
- b. Only adult involvement with the broadcast is as a supervisor.
- c. All live or delayed streaming of the broadcast must be streamed and archived on TribLIVE High School Sports Network.
- d. Any adult working a position on the broadcast other than supervising **disqualifies** the production from being classified as student run and is subject to 100% of the non-affiliate fees specified in the sections above.

## **2. Student Run Production - DELAYED TELECASTING:**

- a. The broadcast is entirely student run with production and broadcast roles occupied by current students only.
- b. Only adult involvement with the broadcast is as a supervisor.
- c. The event must be televised at no charge to viewers only over school-owned station or community access channel in the community of the member school participating.
- d. The telecast/cablecast cannot include commercials.
- e. Any broadcast done on a DELAY basis cannot air earlier than twelve (12) hours after the scheduled starting time of the event.
- f. Any adult working a position on the broadcast other than supervising **disqualifies** the production from being classified as student run and is subject to 100% of the delayed broadcasting fees specified in the sections above.

The rights fee for a LIVE Telecast/Cablecast of an event, even if produced by a student run production crew, will be 100% of the fee specified in Section C – 1, 2, and 3.

## **E. COMMUNITY ACCESS TELEVISION**

Community Access Telecast/Cablecast broadcasts are subjected to the applicable rights fees listed above.

If the broadcast is airing on television only, inquiries about fees and permissions must go through the WPIAL office.

If a broadcast by a community access channel is ALSO being streamed online, it is subject to the corresponding non-affiliate rights fees and conditions in the rights fee schedule as specified above. In accordance to the WPIAL MEDIA POLICY, all streaming is required to be done exclusively through TribLIVE High School Sports Network.

## **F. COMMERCIAL TELEVISION**

All cablecasting/telecasting through mainstream commercial television, must go through the WPIAL office. Applicable LIVE TV Rights Fees will apply, and stations must adhere to the WPIAL MEDIA POLICY.
